UNDERGRADUATE STUDIES - ACADEMIC YEAR 2022-2023

1. REGISTRATION

■ **New undergraduate students**

A. *Regular registration period*

- First phase: from 7 to 11 July 2022
- Second phase: from 14 to 15 July 2022
- Third phase: from 20 to 21 July 2022
- Fourth phase: from 25 to 26 July 2022

B. *Extraordinary registration period*

- First phase: from 2 to 6 September 2022
- Second phase: from 9 to 12 September 2022

*Updated waiting list for preferred options (listas de resultas)*

The registration period for students admitted from the waiting list for preferred options (*listas de resultas*) will be indicated in the ANNEXE “*Fechas y plazos para la Preinscripción del curso 2022/2023*” (Pre-registration periods and deadlines for the academic year 2022/2023) to the Resolution of 21 December 2021, of the Andalusian Directorate General for Universities, announcing the Agreement of 2 December 2021, of the “Distrito Único Andaluz (DUA)” Committee for University Admissions in Andalusia, on the admissions procedure for undergraduate studies during the academic year 2022-2023.

■ **Undergraduate students registering on second or subsequent years**

A. *Online self-registration with prior application and allocation*

- Application period: from 25 July to 5 August 2022
- Allocation of places: 2 September 2022
- Notification of allocations and acceptance of registration: from 5 to 9 September 2022

B. *Online self-registration. Registration modification period. Self-registration period for mobility students (courses to be taken at the host university)*

- From 12 to 16 September 2022

C. *In-person registration (only for justified reasons)*

- Until 14 October 2022



*D. Registration modifications completed by students*

- From 20 to 27 February 2023

Students are not allowed to complete the online modification process for some undergraduate courses during the established regular periods (e.g. work placement or undergraduate dissertation courses, which require students to fulfil specific requirements before registering). For these cases and on an exceptional basis, we offer students the possibility to modify their registration through the UGR e-Administration Platform.

**3. ASSESSMENT PERIODS<sup>2 3</sup>**

**Note:** A minimum period of seven calendar days must elapse between the communication of grades obtained in evaluation exercises from ordinary assessment sessions (*convocatorias ordinarias*) and the initiation of evaluation exercises that are part of extraordinary assessment sessions (*convocatoria extraordinaria*). Likewise, the lecturers responsible for each course must inform the students of their final grade within 20 calendar days from the date of the evaluation exercise.

**4. APPLICATION PERIODS FOR THE RECOGNITION OF CREDITS**

**4.1 First phase**

- From 1 September to 14 October 2022

Applications from students who, due to exceptional circumstances, enrol after the application deadline, will be allowed after this date.

**4.2 Second phase**

- From 7 to 17 February 2023

**5. APPLICATION PERIOD FOR THE RECOGNITION OF CREDITS ON THE BASIS OF OTHER ACTIVITIES**

Applications will be accepted within the period established by each faculty or school, starting from 2 November 2022<sup>4</sup>

**6.3 Third phase**

- From 11 to 15 September 2023

**7. APPLICATION PERIOD FOR SPECIAL ASSESSMENT SESSIONS (*EVALUACIÓN EN CONVOCATORIA ESPECIAL*)**

- From 1 to 7 October 2022

Exceptionally, for undergraduate dissertations, the application period for special assessment sessions will take place earlier: from 21 to 30 September 2022.

**8. APPLICATION PERIOD FOR LAST EXAMINATION OPPORTUNITIES (*EVALUACIÓN EN CONVOCATORIA DE GRACIA*)**

- Applications must be submitted at least 15 calendar days before the start of the exam period in which the student wishes to be assessed.

**9. APPLICATION PERIOD FOR ACADEMIC RECORD TRANSFERS AND ADMISSION OF STUDENTS WHO HAVE DISCONTINUED THEIR STUDIES DUE TO NON-COMPLIANCE WITH THE UGR CONTINUANCE REGULATIONS**

- From 26 June to 7 July 2023

**10. APPLICATION PERIOD FOR ADMISSION OF STUDENTS WHO HAVE COMPLETED PARTIAL OR FULL FOREIGN UNIVERSITY PROGRAMMES WHICH HAVE NOT BEEN OFFICIALLY RECOGNISED**

- From 16 January to 10 March 2023

For the purposes of the academic calendar, regional and local public holidays in Granada will be replaced by the respective applicable holidays on the Ceuta and Melilla campuses.
